**Q:** I have a Japanese maple in a pot. I'm thinking about planting it in the ground. When is the best time to replant? Susan

A: Dear Susan

As with most trees, the best time to replant is in the late winter be-

fore root grow begins for the new season. If the plant is terribly root bound, you might need to make an exception. Take a picture next year after you replant it, and let us know how it thrives!

### **MAY PLANT**

Maple, Japanese Red *Acer palmatum var. atropurpureum* 

#### **Description-**

Japanese maples have beautiful red leaves in the spring and fall that might turn



somewhat green in the summer. Atropurpureum is more cold hardy than some of the other hundreds of varieties available of Japanese maples. Zones 5-8. The species name "palmatum" refers to the hand-like shape of the leaves. It actually has very small red flowers that bloom at the same time as the red leaves unfurl. Maybe someone could snap a picture of the flower?

**Growing tips:** The ideal soil is slightly acidic and well-drained sandy loam, but other soils are tolerated. Plant in full sun or partial shade, with protection from the hot afternoon sun. Many in my neighborhood are doing well on the east side of houses. Water here in Lake County's hot summers and do mulch to help retain soil moisture.

**Prune-** Maples can be pruned to be shrub-like or tree like so that adds to its versatility. At maturity it can reach 15 to 25 feet tall.

**Propagation**- The winged seeds will be the best way to start a new tree. They ripen in the early autumn. The seeds are small, so don't plant them too deep.

Flourless Peanut-Chocolate Cookies - 24 Submitted by Linda Pyers

1 C crunchy peanut butter

3/4 C sugar

1 large egg (lightly beaten)

1/2 tsp baking soda

1/4 tsp salt

3/4 C semisweet chocolate chips

Preheat oven to 350 degrees. Mix first five ingredients. Stir in chips. Roll dough into balls. Place 2 inches apart on two baking sheets. Bake until cookies are golden and puffed, 12-14 minutes, rotating sheets from top to bottom and front to back halfway though. Cool 5 minutes on sheets; transfer to racks to cool.

I will not be able to attend that meeting, but I wrote Virginia the following response, and I want to keep you all in the loop.

Virginia,

I talked to Rita, CGCI president elect. She said if we have an inactive club, individual clubs can still get insurance and continue with the non-profit status. LA County apparently has only the treasurer in place. She also said the convention next year will be in Reno at Circus Circus at \$56 a night in case that's an incentive? She, of course, hopes we will continue and remembers the trip she took here to the CLTTGC last year with fond memories.

Having an inactive District would probably impact the individual clubs the least. Clubs could decide to or not to do all that the state wishes.

I have a local insurance agent looking to see how much liability insurance might cost, with and without non-profit status.

Many members have talked to me about leaving the district and CGCI. I would guess others would like to remain as part of the CGCI especially as we could still send in awards, and we can buy their inexpensive insurance. Even if it doesn't help much or really at all, it does allow us to have insurance for places that require it, like the Grange where we have our Daffodil Tea and our Wreath making. (It does say right on the website that our homeowners are the primary on claims if our meetings are at our houses. I feel like the people who come to my house for Garden Club events are my friends, and I doubt they would sue me, but if they did, that is what insurance is for.)

My plan is to put forth to the club the pros and cons after I get information together.

Conducting business by email, saves miles and wear and tear on people and cars. I do like that suggested change to the District Bylaws, as well as, the other suggested changes. (Note: Those include making many of the meetings and state obligations not mandatory but voluntary.)
